SECTION 2. RNG COMPONENTS INSPECTED

The following RNG certificate has been inspected for validity and is relied on for the game included in this certification (Refer to Schedule 1 for the detailed RNG information):

RNG Tests Performed

The scope of the evaluation consisted of an assessment of the following components:

- Documentation;
- Source code;
- Statistical and mathematical analysis;
- Seeding/re-seeding;
- RNG range; and
- RNG scaling

The RNG certificate was evaluated to ensure the following requirements were met:

- The random selection number shall be statistically independent
- The data must be randomly generated;
- The data must be unpredictable;
- The series cannot be reproduced;
- The game outcome produced by the random selection number generator shall correspond to a test result obtained by means of a random selection series of tests; and
- The checksum of the interactive game programme and each of its components shall be displayed as a code as determined by the producer.

The test suite used to perform the evaluation included the following:

- Chi-Squared Tests;
- Wald-Wolfowitz (or Runs) Tests;
- · Expected probabilities for shuffle decks; and
- Diehard Test Suite.

Test Results

A source code assessment, documentation review and recognised statistical and mathematical tests were performed to certify the RNG operated in compliance with the requirements stipulated in the regulations of highly regulated online gambling jurisdictions. This included tests for probability (to ensure the expected number of occurrences), randomness (so that one cannot predict the following occurrence with any degree of certainty) and uniformity (to determine that each possible outcome is equally likely over the long-term). The acceptance criteria for the statistical tests is a pass at a 95% confidence level.

The test results for AlchemyBet Ltd RNG product produced statistically acceptable random numbers that were free of any significant statistical bias or predictability.



SECTION 3. DETAILS OF TESTS PERFORMED

AlchemyBet Ltd requested eCOGRA to evaluate the Other, HTML5-Desktop; HTML5-Mobile game, for satisfactory operation in compliance with the Lotteries and Gambling Supervisory Inspection relevant sections of the Gambling and Lotteries Law and Regulations 786, 715, 188 and 189.


