- Core game services;
- Game front-end; and
- Application programming interface.

3. TEST DETAILS

eCOGRA has been appointed by AlchemyBet Ltd to certify the following games for compliance with the applicable regulations, and to highlight any exceptions identified during testing.

This certification report highlights our key findings as a result of the evaluation conducted on a test environment which is representative of the live environment where the game operates. The testing was conducted on the aforementioned platform established at AlchemyBet Ltd during the period 24 April 2023 to 12 May 2023.
